



Vital to the Future of Arizona?

The Arizona Rock Products industry includes; sand and gravel mining firms, crushed stone producers, ready-mix concrete suppliers, asphaltic and concrete product manufacturers, cement producers, consultants and suppliers to the industry. Combined, these firms employ 6,124 Arizona workers who provide essential materials for an additional 112,361 workers in the construction industry of the Grand Canyon State. The Rock Products Industry

had a recorded significant growth in the past decade, until residential housing weakened in Arizona. Overall Arizona employment fell by 11 percent between 2007 and 2010, however rock products jobs decreased by 46 percent.

The value of direct output, production and deliveries of the Arizona Rock Products industry was \$1.6 billion in 2010, down by 61 percent from the peak in 2006, according to the U.S. Geological Survey. The total economic impact of the Rock Products industry, incorporating multiplier effects was \$2.9 billion dollars in 2010.

These revenues were disbursed back into the Arizona economy as expenditures for personnel, materials, supplies, equipment, fuel, utilities, leases, services and payments to governments.

Taxes and fees paid to state, local, and federal governments by firms in the Rock Products industry totaled well over \$98.8 million dollars.
